DIRECTIONS FOR USE

Dilute 25-50 times with water. Adjust dilution ratio according to the growing stage of weeds.

2-4 Litres of concentrate makes up to 100L of spray.

- Spray thoroughly on both surfaces of leaves.
- Do not use it with alkaline materials.
- PH value of dilution water should ≤ 7 .
- For best results apply spray before several hours of sunlight.
- Avoid rain.
- Avoid polluting fishponds and watercourses

STORAGE

Store in a dark, cool dry place, away from direct sunlight. Keep away from food and animal feedstuffs. When stored correctly this product should show no signs of degradation for 2 years from date of manufacture.

DISPOSAL

Do not dispose of container until all of the contents have been used. Triple rinse and crush or puncture container before disposal or return empty container to supplier. Dispose of unwanted product as a hazardous waste.
